Articles of Faith

I. Of the Scriptures:

¹We believe that the Holy Bible was written by men divinely inspired, and it is a perfect treasure of heavenly instruction; ²that it has God for its author, salvation for its end, ³and truth without any mixture of error for its matter; ⁴that it reveals the principles by which God will judge us; ⁵and therefore is, and shall remain to the end of the world, the true center of Christian union, ⁶and the supreme standard by which all human conduct, creeds, and opinions should be tried.

II. Of the True God:

¹We believe that there is one, and only one, living and true God, ²an infinite, intelligent Spirit, whose name is JEHOVAH, ³the Maker and Supreme Ruler of Heaven and earth; ⁴inexpressibly glorious in holiness, and worthy of all possible honor, confidence, and love; ⁵that in the unity of the Godhead there are three persons, the Father, the Son, and the Holy Ghost; equal in every divine perfection, ⁶and executing distinct and harmonious offices in the great work of redemption.

III. Of the Fall of Man:

¹We believe that man was created in holiness, under the law of his Maker, ²but by voluntary transgression fell from that holy and happy state; ³in consequence of which all mankind are now sinners, not by constraint but choice; ⁴being by nature utterly void of that holiness required by the law of God, positively inclined to evil; ⁵and therefore under just condemnation to eternal ruin, without defense or excuse.

IV. Of the Way of Salvation:

¹We believe that the salvation of sinners is wholly of grace; through the mediatorial offices of the Son of God; ²who by the appointment of the Father freely took upon Him our nature, yet without sin; ³honored the divine law by His personal obedience, and by His death made a full atonement for our sins; ⁴that having risen from the dead, He is now enthroned in heaven; ⁵and uniting in His wonderful person the tenderest sympathies with divine perfections, He is every way qualified to be a suitable, a compassionate, and an all sufficient Saviour.

V. Of Justification:

¹We believe that the great gospel blessing which Christ secures to such as believe in Him is justification; ²that justification includes the pardon of sin, and the promise of eternal life on principles of righteousness; ³that it is bestowed not in consideration of any works of righteousness which we have done, but solely through faith in the Redeemer's blood; ⁴by virtue of which faith His perfect righteousness is freely imputed to us of God; ⁵that it brings us into a state of most blessed peace and favor with God, and secures every other blessing needful for time and eternity.

VI. Of the Freeness of Salvation:

¹We believe that the blessings of salvation are made free to all by the gospel; ²that it is the immediate duty of all to accept them by a cordial penitent, and obedient faith; ³and that nothing prevents the salvation of the greatest

sinner on earth but his own inherent depravity and voluntary rejection of the gospel; ⁴which rejection involves him in an aggravated condemnation.

VII. Of Grace in Regeneration:

We believe that in order to be saved, sinners must be regenerated, or born again; that regeneration consists in giving a holy disposition to the mind; that it is effected in a manner above our comprehension by the power of the Holy Spirit, in connection with divine truth, so as to secure our voluntary obedience to the gospel; and that it's proper evidence appears in the holy fruits of repentance, and faith and newness of life.

VIII. Of Repentance And Faith:

We believe that repentance and faith are sacred duties and also inseparable graces, wrought in our souls by the regenerating spirit of God; whereby being deeply convinced of our guilt, danger, and helplessness, and of the way of salvation by Christ, we turn to God with unfeigned contrition, confession, and supplication for mercy; at the same time heartily receiving the Lord Jesus Christ as our Prophet, Priest and King, and relying on Him alone as the only and all-sufficient Saviour.

IX. Of God's Purpose Of Grace:

We believe that election is the eternal purpose of God, according to which He graciously regenerates, sanctifies, and saves sinners; that being perfectly consistent with the free agency of man, it comprehends all the means in connection with the end; that it is a most glorious display of God's sovereign goodness, being infinitely free, wise, holy and unchangeable; that it utterly

excludes boasting, and promotes humility, love, prayer, praise, trust in God, and active imitation of His free mercy; that it encourages the use of means in the highest degree; that it may be ascertained by its effects in all who truly believe the gospel, that it is the foundation of Christian assurance; and that to ascertain it with regard to ourselves demands and desires the utmost diligence.

X. Of Sanctification:

¹We believe that sanctification is the process by which, according to the will of God, we are made partakers of His holiness; ²that it is a progressive work; ³that it is begun in regeneration; ⁴and that it is carried on in the hearts of believers by the presence and power of the Holy Spirit, the Sealer and Comforter, in the continual use of the appointed means – especially the Word of God, self-examination, self-denial, watchfulness, and prayer.

¹We believe that such only are real believers as endure unto the end; ²that their persevering attachment to Christ is the grand mark which distinguishes them from superficial professors; ³that a special providence watches over their welfare, and that they are kept by the power of God through faith unto salvation.

XII. Of the Harmony of the Law and the Gospel:

¹We believe that the law of God is the eternal and unchangeable rule of His moral government; ²that it is holy, just, and good; ³and that the inability which the Scriptures ascribe to fallen men to fulfill its precepts, arises entirely from their love of sin; ⁴to deliver them from which, and to restore them through a Mediator to unfeigned obedience to the holy law is one great end of the gospel and of the means of grace connected with the establishment of the visible church.

XIII. Of a Gospel Church:

¹We believe that a visible church of Christ is a congregation of baptized believers, associated by covenant in the faith and fellowship of the gospel; ²observing the ordinances of Christ; ³governed by His laws; and exercising the gifts, rights, and privileges invested in them by His word; ⁴that its only scriptural officers are bishops or pastors and deacons, whose qualifications, claims, and duties are defined in the Epistle to Timothy and Titus.

XIV. Of Baptism and the Lord's Supper:

¹We believe that Christian baptism is the immersion in water of a believer, in the name or the Father, and Son, and Holy Ghost; ²to show forth in a solemn and beautiful emblem, our faith in the crucified, buried and risen Saviour, with its effect, in our death to sin and resurrection to a new life; ³that it is prerequisite to the privileges of a church relation; ⁴and to the Lords Supper in which the members of the church by the sacred use of bread and wine, are to commemorate together the dying love of Christ; preceded always by solemn self-examination.

XV. Of the Christian Sabbath:

¹We believe that the first day of the week is the Lord's Day or Christian Sabbath; ²and it is to be kept sacred to religious purposes, by abstaining from all secular labor and sinful recreations, by the devout observance of all the means of grace, both private and public; ³and by preparation for that rest that remaineth for the people of God.

XVI. Of Civil Government:

¹We believe that civil government is of divine appointment, for the interests and good order of human society; ²and that magistrates are to be prayed for, conscientiously honored, and obeyed; ³except only in things opposed to the will of our Lord Jesus Christ, who is the only Lord of the conscience, and the Prince of the kings of the earth.

XVII. Of the Righteous and the Wicked:

¹We believe that there is a radical and essential difference between the righteous and the wicked; ²that such only as through faith are justified in the name of the Lord Jesus, and sanctified by the Spirit of our God, are truly righteous in His esteem; ³while all such as continue in impenitence and unbelief are in His sight wicked, and under the curse, and this distinction holds among men both in and after death.

XVIII. Of the World to Come:

¹We believe that the end of this world is approaching; ²that at the last day Christ will descend from heaven, and raise the dead from the grave to the final retribution; ³that a solemn separation will then take place; that the wicked will be adjudged to endless punishment, and the righteous to endless joy; ⁴and that this judgment will fix forever the final state of men in heaven or hell, on principles of righteousness.

XIX. Of Marriage:

¹We believe that marriage is a divinely established union. That it is defined in the Holy Scriptures as being between one natural born man and one natural born woman. ²Marriage is the foundational relationship of the natural family. The Scriptures teach that it was instituted to combat loneliness through companionship, to prevent sexual immorality and to populate the earth. ³That it is for the mutual benefit of the man and the woman and is intended to give glory to God. ⁴We believe that it is a lifelong union. ⁵That the ultimate purpose of marriage is to reflect the relationship that Christ has

with His bride, the church and to pervert this relationship is to distort the gospel message.

XX. Of The Sanctity of Human Life:

¹We believe that mankind was made in the image and likeness of God and that human life is sacred and holy. ²In the creation, mankind was given dominion and priority over the animal kingdom. ³Human life is highly valued by God and should therefore be protected in every stage. ⁴We believe that life begins at conception and ends at a time appointed by God. ⁵We believe that mankind was created with the purpose of glorifying God and that innocent human life should not be devalued or destroyed. In every stage it should be protected and nurtured to fulfill the purpose for which it was originally created.

CONSTITUTION

Article I: This body shall be known as the Bethel Missionary Baptist Association.

Article II: These Associations shall be composed of members duly chosen by regular and orderly Missionary Baptist Churches.

Article III: The letters from the Churches to the Association shall give the number of members in fellowship, received by experience and baptism, received by letter, restored, excommunicated, and dead, since last annual meeting and mission work supported with financial information.

Article IV: Each Church shall be entitled to six messengers or alternates who shall serve in the absence of messengers.

Article V: These Associations shall elect annually as officers, a Moderator, Clerk and Treasurer, chosen from their memberships, whose duties shall be to serve their brethren in their several capacities.

Article VI: These Associations shall never interfere with the independence of any Church, or claim any ecclesiastical power or rights of supervision over any of the Churches.

Article VII: It shall be the object of these Associations to promote the union of the faith of the gospel with our educational and mission interest.

Article VIII: These Associations shall meet annually on the Friday before the third Sunday at 10 a.m., Friday evening at 7 p.m. and Saturday morning at 10 a.m. at a location agreed upon by the Association.

Article IX: Messengers from one third of the Churches shall constitute a quorum for transaction of business at any regular meeting.

Article X: These meetings shall be missionary.

Article XI: New Churches shall be admitted into this Association, who shall petition by letter and messengers, and on examination, if found orthodox and orderly, may be received and made known by the Moderator giving the right hand of fellowship to the messenger or messengers present.

Article XII: The Association may exclude from the union any Church or Churches that are heterodox in principle or disorderly in practice.

Article XIII: The Association at its sitting may admit any visiting brethren and sister, from sister churches present, to sit with them, who shall have liberty to discuss any question and give their views, but not to vote except upon subjects of general union.

Article XIV: Any alteration may be made to the constitution at any regular meeting by a two thirds majority vote of members present.

Article XV: That all questions arising before this Association be decided by a greater number of the vote of the messengers present, including the reception of Churches into our Fellowship.

Amendments

Ninth Session

I: Be it resolved that any Church having been admitted into the membership of the Association, if said Church fails to present a letter to the Association for three consecutive years, that said church shall be removed from the membership of the Association.

Tenth Session

II: Those assigned to a subject will prepare it, or the Moderator be allowed to appoint a committee to write one to read before the Association.

Eleventh Session

III: In the electing of officers, if anyone elected to an office or to preach a sermon does not have an assistant or alternate, one shall be appointed by the Moderator.

Twelfth Session

IV: That the Clerk have the authority to print the obituary and picture, if the family so desires, of deceased members in the fellowship of the Association in the minutes from this time on.

V: In the seating of visitors, the Moderator has the right to question them as to their acceptance of alien immersion, and to deny them the privilege of being seated if they do accept or fellowship alien immersion.

Eighteenth Session

VI: The Clerk has the authority to dispose of the handwritten copies of our minutes after being kept a minimum of two years.

Nineteenth Session

VII: The time spent reading associational letters be shortened by reading the greeting from the first letter and omitting all addresses and the list of ordained and licensed preachers.

Thirty-Seventh Session

VIII: That a report, presented in writing, concerning the status of missions, missionaries, their addresses, their financial needs and progress of their work be always included in the list of subjects for discussion.

Forty-Seventh Session

IX: No proceedings shall be had against any Church, except of charges preferred by a sister church, which shall first have attempted reconciliation before bringing the issue before the Association.

Forty-Ninth Session

X: An offering is to be collected on Saturday and split between all of the missionary efforts within the Association.

Fifty-Fourth Session

XI: The letters from the Churches to the Association shall give the number of members in fellowship, received by experience and baptism, received by letter, restored, excommunicated, and dead, since last annual meeting, and mission work supported with financial information

Fifty-Seventh Session

XII: No preacher shall preach two years in a row.

Fifty-Eighth Session

XIII: The missionary collection shall take place after the unfinished subjects during the Saturday morning session of the Association meeting.

Rules of Decorum

I: The Association shall be opened and closed in prayer.

II: Only one person shall speak at a time, who shall arise and address the Moderator by the appellation of Brother Moderator, and shall, while speaking, confine himself to the subject under discussion and shall not be interrupted unless he digress from the subjects, and shall in no wise reflect on any other speaker, so as to make remarks on his slips, failings or imperfections, but shall fairly state his views without sophistry or criticism.

III: No member shall absent himself from the Association without leave of the Moderator.

IV: No member shall speak more than three times on the same subject without leave of the body. The chairman of each subject shall have an opening speech of ten minutes and two other speeches of five minutes each

V: Each motion and second shall come under the immediate consideration of the Association, unless withdrawn by the one who made it.

VI: All members shall conduct themselves in these sessions in a manner conducive to Godliness.

VII: No member shall address another by an appellation other than that of Brother.

VIII: On the first day it shall be the duty of the clerk to read the Rules of Decorum and call the roll of messengers.

IX: The Moderator shall be entitled to the same privileges of speaking as any other member, provided the chair be filled, but shall have no vote unless the Association is equally divided.

X: Any member violating these rules, or any time manifesting a spirit contrary to the gospel, shall be reproved or such other course taken with him as the Moderator may think proper, either of his own option or the initiation of any other member.

Meeting Minutes

Friday, September 13th, 2019

Morning Session

The 62nd Annual Session began by Brother Scott Hauskins leading *I'll Have A New Life*, and *When God Dips His Love In My Heart* with the assistance of Brother Danny Edwards on the piano.

Brother Rich Jenkins came forward to welcome the churches to the 2019 Association. He went over the accommodations and a brief overview of the day. He thanked God for being able to host and that God has already blessed Salem. Brother Rich then turned the moderator duties to the Moderator Brother Jeff Moran. Brother Moran thanked God for the opportunity and for all the churches that were able to be here. "How good and how pleasant it is for brethren to dwell together in unity!"- Psalm 133:1

After the scripture reading, Brother Moran opened the floor for prayer requests. After several requests, Brother Moran asked Elder Don Watts to lead the congregation to the Lord in prayer. After prayer, it was requested that we sing Victory Was Won At Calvary. Brother Cory Houchens lead with Brother Brad Hicks playing the piano. Following the song, Elder Jeremy Miller came forward to preach the introductory sermon.

Introductory Sermon

Elder Jeremy Miller

After some opening remarks and thanking the churches for the opportunity to stand for the Lord, he began by reading Revelation 12:7-17. He stated that some things in the book of Revelation are hard to understand, but there are some things that he does understand. He said that the present state of this world is in decay; the devil has come to this Earth and is trying to destroy the people of God. The chosen scripture is about a great conflict in heaven and the center of the conflict is Satan. No matter what Satan knows that he is defeated, but he is still trying to fight the war. He convinced a third of the heavenly angels to rebel against God, but he was defeated by Michael and his angels through the Blood of the Lamb. Satan was then cast out and he chose to take up the war here on Earth.

Satan has his devices. Firstly, he is very cunning and skilled in deceitfulness and through his lies. He was cunning in the beginning and he still uses his abilities to cause issues. In the beginning, he deceived the first humans to go against the desire of God. Satan's rebellious nature influenced Adam and now mankind carries that rebellious desire in our hearts. The 12th verse states "...woe to the inhabiters of the earth and of the sea! For the devil is come down unto you, having great wrath, because he knoweth he hath a short time."

He stated that our churches should take a stand to recognize sin and all the influences of the devil. We should point out that the love of the world is sin! Our war is spiritual, and it should be fought in a spiritual fashion. Brother Jeremy called this war "The Great War." World War I was referred to as this, but this war is a war for the souls of men. This war effects every child that has ever been born. Brethren let us not be ignorant to the fact that this war is a battle that is fought on all fronts every single day. We must warn souls of the wrath of God that is to come to wipe out sin forevermore. Il Corinthians 4:3-4 states, "But if our gospel be hid, it is hid to them that are lost; In whom the god of this world hath blinded the minds of them which believe not, lest the light of the glorious gospel of Christ, who is the image of God, should shine unto them."

Brother Jeremy then read from Ezekiel 28 to explain the attributes of the devil. Some things that we need to remember is that he is not omnipotent, he is not omniscient, and he is not omnipresent. Only God himself has those attributes. The devil is a created being of God and he has limited power, but he does have power.

As a reminder to us as believers, we need to remember that we are not alone to fight this battle. If we attempt to fight it alone, we are destined to fail. However, we have a Captain in this battle, the "Captain of our salvation." Our captain goes before us like a Good Shepherd. In Hebrews 2, the writer speaks about the qualifications of Jesus Christ to be our captain, or shepherd. He stated that it is good to be in God's army. God is a good general that takes care of his soldiers. He mentioned that in World War II that there were soldiers on the opposing side that were almost glad to be captured by America or surrender to our armies. Much the same as we put on Christ's uniform, we are made very glad and are now symbolic to the world of Christ.

He concluded by saying we need to call upon the Lord and ask for his assistance daily. Our battle is too great by ourselves, but we can do all things through Christ who strengthens us. (find a video of the full sermon online at www.bethelmba.com)

Following the sermon, our moderator, Elder Jeff Moran thanked God for the good message. He asked that we have a song and invited Brother Cory Houchens and Brother Brad Hicks to come forward to lead *Hallelujah*, *What A Savior*.

After the song and several wonderful testimonies, Brother Moran invited our clerk pro temp, Brother Jeremy York, to come forward to read the rules of decorum. Moderator Moran then appointed Elder James Whitney, Elder Bruce Adamson, and Elder Jeremy Collins as the subject selection committee for 2021.

Elder Moran then called on Brother Cory Houchens, with Brother Brad Hicks accompanying to lead I Call it Home and Victory in Jesus to allow for the congregation to pass by and shake hands with Brother Jeremy Miller. After the handshake and songs Brother Moran then called upon Brother Bruce Adamson to dismiss the morning session and pray a blessing over lunch.

Afternoon Session

After returning from lunch, Brother Jeff Brown opened the afternoon session by leading *I See Jesus* and *Rock of Ages* with Brother Danny Edwards accompanying on the piano. Following the songs, Brother Moran thanked all of those who put effort into the lunch, and called the association back to order. He asked Brother Rick Huskins to lead our hearts in prayer.

After prayer, Brother Jeff asked Brother Nick Reuter to come forward and present the first subject "*Cultural Philosophies in the Church*".

Cultural Philosophies in the Church

- 1. Identify and thoroughly define the cultural philosophies that are infiltrating and impacting the church.
- 2. Prescribe what the church can do to overcome the challenges presented by these philosophies

The first part of our subject requires us to identify and thoroughly define the cultural philosophies that are infiltrating and impacting the churches. The term "infiltrating" seems to carry with it an implication that such philosophies or "wisdom of this world" are impacting God's people in a negative way. That being said, we will seek to call out some of the harmful ideas of our culture. As we will see, they are harmful inasmuch as they are a departure from the truth of God's word. Upon immediate consideration, this would seem to be a daunting task. Our culture and, regrettably, our people are "carried about with every wind of doctrine," (Eph. 4:13). The task appears less daunting upon realizing "there is no new thing under the sun," (Ecc. 1:9-10). Satan seems to reuse and recycle philosophies as it suits his purposes within a culture. Still, we will not consider the list provided in this report to be a complete list. Yet, hopefully, it will evoke some thought and prompt some much needed discussion about our people's departure from the Lord in worldview and practice.

Individualism, As Manifested in Self-Worship

Merriam-Webster defines individualism as, "a doctrine that the interests of the individual are or ought to be ethically paramount," (Merriam-Webster, 2019). Each person is made in the image of God, and Christ died for every individual. Every soul is immeasurably precious to God and ought to be regarded as such. However, each person has an undeniable tendency to promote one's self at the expense of God's glory and the welfare of his or her neighbor. We could say that "self" is the motive behind every sin committed against God and neighbor. This type of self-worship is evidenced in our culture by the tendency of people to serve themselves more than their Creator (Rom. 1:25) and to say "Not Thy will but mine!" In an effort to consider how "self-worship" has impacted our people, please reflect on the list of issues below. The issues listed are likely influenced by any number of things. However, it could be they are signs and symptoms that we have taken individualism to its extreme.

- Hypersensitivity/Inability to take instruction or constructive criticism
- Meager Giving
- Living Beyond Means/Accumulation of Consumer Debt
- Church Absenteeism
- Weakened or Non-existent Sense of Community in the Churches
- Obsession with Social Media
- Loving Entertainment/Other Pleasures More than God as Evidenced by our use of Time
- Misusing the Lord's Name by Saying, "The Lord told me..." in Order to Justify our Self-Motivated Decisions

Moral Relativism, A Fruitless Tree with Many Branches

"Moral relativism is the view that moral or ethical statements, which vary from person to person, are equally valid and no one's opinion of "right and wrong" is really better than any other," (AllAboutPhilosophy.org). If this ideology is carried to its inevitable conclusion, then anything and everything are permissible. Furthermore, those who make exclusive truth claims (ie. "This is right, but that is wrong") are viewed as and proclaimed to be intolerant, prejudiced, ignorant, and even hateful. This being the case, many people, and yes, even our people, are much more willing to participate in the unfruitful deeds of darkness rather than expose them for what they are (Eph. 5:11). Even if our people are not actively participating in the societal ills listed below, it is feared we are a long way from declaring, "Awake, sleeper, and arise from the dead, and Christ will shine on you," (Eph 5:14). We are afraid of the opinions of others much more than He who has power to confess or deny us before the Father in heaven (Matt. 10:33). When a brother or sister says, "I don't agree with that, but I will not judge you for doing it," at least two evils are committed. First, the erring soul is kept in the dark because we decided to cover up our light with a basket. Second, we have perpetuated the lie of moral relativism. What we have communicated to the erring person is, "you can have your truth, and I will have mine." We should love God and people better.

Moral relativism is here called a fruitless tree with many branches because it opens the floodgates for the allowance of any philosophy and all sorts of societal ills. As we consider the list below, have we exposed the darkness or been content to let ourselves and others dwell in it?

- A Woman's Right to Elective Abortion/Infanticide
- Transgenderism
- Homosexuality
- Marital Infidelity
- Sexual Promiscuity
- Living Together/Cohabitation
- Unbiblical divorce
- o Irrelevance of Organized Religion

The Attack on Masculinity, the Deconstruction and Demeaning of Manhood.

The Apostle Paul told the Corinthian church, "Be on the alert, stand firm in the faith, act like men, be strong. Let all that you do be done in love," (1 Cor. 16:13-14). The Scriptures inform us on what a man is to be, and what his role is. If we ever find ourselves at a loss in trying to ascertain what godly manhood looks like, we need look no further than the God-man, Jesus Christ. He is our standard (Eph 4:13, Rom. 8:29). Our culture is in a state of confusion, as the male gender role has been deconstructed. In their Guidelines for Psychological Practice with Boys and Men, the American Psychological Association maintains that, "psychologists aspire to help boys and men over their lifetimes navigate restrictive definitions of masculinity and create their own concepts of what it means to be male, although it should be emphasized that expression of masculine gender norms may not be essential for those who hold a male gender identity," (American Psychological Association, Boys and Men Guidelines Group, 2018; emphasis added). Not only is masculinity deconstructed by academia, but men are openly ridiculed by the media and

entertainment industry. Who hasn't seen a sitcom in the last 20 years featuring an unintelligent, lazy, unattractive, or incompetent male as the source of humor? It is no wonder that gender roles are confounded.

Our boys must have their character intentionally shaped and their roles defined. Failure to do so will result in weak leadership in their homes, their churches, and their communities. Our women must beware of believing or perpetuating what the media and entertainment industry say about men. The culture has conditioned women to resist male leadership. This can have disastrous consequences for our homes and churches.

"Come, let us return to the Lord. For He has torn us, but He will heal us; He has wounded us, but he will bandage us," (Hos.6:1).

The second part of our subject requires us to prescribe what the churches can do to overcome the challenges presented by these philosophies. We will look at Paul's urgent plea found in Romans 12, and how it may be obeyed by the individual. We will also examine some other contexts or spheres of influence each church member may fall under. We will look to the Scriptures for what we ought to do in each context/sphere of influence. A few practical instructions or resources will also be suggested to aid us as we try to overcome the challenges presented by these philosophies.

"It Starts with Me."

"And do not be conformed to this world, but be transformed by the renewing of your mind, so that you may prove what the will of God is, that which is good and acceptable and perfect," (Rom. 12:2).

We must not be like the world in thought, speech, or action. Instead, we are to be transformed by the renewing of our mind. Proving God's perfect will for ourselves, our people, and our neighbors in this world begins with our minds being renewed. This transformation is a work of the Holy Spirit in us (Rom 8:11). It is God who works in us both to be willing and to do according to His good pleasure (Phil 2:13). We must depend on God to transform us. Yet, God expects certain effort from us for this to be accomplished. What are some of the means which God intends to use as He supernaturally transforms us? Our article of faith on Sanctification, taken from the New Hampshire Confession of Faith, lists several things God has appointed for the believer to use continually:

- The Word of God (Ps 1:1-3; Mt. 4:4; Jn. 15:7; Jn. 17:17)
- Self-Examination (Ps 139:23-24; 1 Cor. 11:28-32)
- Self-Denial (Lk. 9:23; Rom. 13:14)
- Watchfulness (Mt. 26:41; Lk. 21:36)
- Prayer (Lk. 11:9-13; Lk. 18:1-8; Eph 6:18; 1 Thess. 5:17)

We would also like to mention **song** as a means of spiritual-mindedness in aligning our hearts and minds with gratitude to God. The Scriptural precedent for this is impressive (Ps. 1-150; Mt. 26:30; Eph. 5:19). It should be noted that not all songs are created equal. With reference to their help with our sanctification, the

Scriptures seem to set forth that the best songs are those that help us to "let the word of Christ richly dwell" in us (Col 3:16).

- Practical Suggestions and Resources
 - PRAY
 - Slow Down and Make Time-Choose what is best.
 - Be Smart with your Smart Phone-Use whatever Apps you may to get the Word in you.
 - "Let's Have a Song"-A day can take a different tone when our hearts look up.
 - Get Alone with God-Do what you must; ask Him to help

Truly, overcoming the challenges presented by our culture's philosophies begins with each of us individually. Yet each one of us has other spheres of influence or contexts in which these same principles ought to be applied. We will address the home, the church member-church member dynamic; the preaching/teaching ministry of the church, and the church-church dynamic.

The Home

The marriage relationship is the foundation of the home and family. Wives are to be subject to their husbands, as to the Lord (Eph. 5:22); A husband is to sacrificially love his wife, be a means of her sanctification, and nourish and cherish her as he would himself (Eph. 5:25-29). The relationship is to be one of such harmony that the two people are said to be "one flesh." In order to depict the relationship between Christ and His Bride, the husband and wife will likely find themselves utilizing the same means of personal sanctification (Scripture, self-denial, self-examination, watchfulness, prayer, song) in the context of the marriage relationship.

The responsibility of raising children "in the discipline and instruction of the Lord" falls upon married couples who are blessed to become parents. More accurately, it lies squarely on the shoulders of fathers (Eph 6:4). Mothers are not exempt from responsibility as they are to be a help to their husband. The Scriptures are ripe with examples of godly mothers who made all the difference concerning the eternal welfare of their children. The goal with raising children is not merely getting them to memorize doctrine or conform to certain patterns of behavior, but that they would belong to Christ, seeking and serving Him all of their days. (Deut. 6:4-9; Ps. 78:1-8; Prov. 23:26)

 - **Be the Example**-"It starts with me." Our spouses and our children need to see us desiring God above all else.
 - Attend a Marriage Retreat/Workshop/Seek Marriage Counseling From a Trustworthy Source-Preventative maintenance can go a long way.
 - "Sacred Marriage" by Gary Thomas- We recommend with mild reservation, but the book is useful for helping couples to see how God intends to use their marriage to sanctify them.
 - "Shooting for the Mark-Aiming for Excellence in Parenting" by James Keen- Elder Keen's book is s great resource for every parent.

- "Bringing up Boys" and "Bringing up Girls" by Dr. James Dobson-We would recommend these books to every parent as they elaborate on many of the cultural influences pitted against our children.
- "Diligence in the Home" a lesson present by Elder Brad Hicks-It is a comprehensive survey on God's will for the Christian home. Many practical suggestions are included.
- Catechizing/ "Old-er Time Baptist" Q&A a method of teaching the essentials of the faith through memorization of answers to specific questions. The record of history shows us that a number of our Spiritual ancestors, like the ancient Waldenses, utilized this teaching method. A sample from Charles Spurgeon's, "A Catechism with Proofs," compiled from The Westminster Assembly's and Baptist Catechisms is as follows:
 - Q. What is the chief end of man?
 - A. Man's chief end is to glorify God, (1 Cor. 10:31) and to enjoy Him forever (Ps. 73:25,26)
- Family Devotions/Worship-This is something many of us covenanted to do
 when we joined the church. Schedule a time and be aware of the dangers
 of overcomplicating.

The Church-Member-Church Member Dynamic

The members of the local body are to be unified, "that the members may have the same care for one another," (1 Cor. 12:25). We are all called to pray for each other (Eph. 6:18), encourage each other (1 Thess. 5:14), admonish each other (Rom. 15:14), serve each other (1 Pt. 4:10), and to do whatever else practical love may require (1 Jn. 3:16-18). Furthermore, Titus chapter two informs us that older men and older women are not only to be exemplars but teachers of good things to the younger (Tit. 2:1-6).

 - PRAY
 - Maximize Opportunities for Church Fellowship-Get to know your fellow members. How can you help them? How may they help you?
 - Practice Hospitality- Have members in your home and look for opportunities to love each other practically.
 - Find Ways to Interact Throughout the Week
 - More than Just "Hanging Out"-Let your conversation be concerning Spiritual things. Let your relationship as brothers and sisters become deeper than the social chatter. Discuss Scripture and how the Lord is working in your daily life.

The Preaching/Teaching Ministry of the Church

Our preachers and our members with gifts of teaching exist to help disseminate the truth of God's word to us. Our pastors and other ministers, like Paul, should not shrink from declaring the whole purpose of God to us (Acts. 20:27). The Apostle did this not only publicly, but in the homes of the believers (Acts. 20:20). Also, churches should not be afraid to utilize those other members of their congregations that have gifts of teaching. The current practice of having Sunday school is a good outlet. We need not think it is the only one.

 - From House to House- Home Bible studies/prayer meetings will strengthen the church bond with one another; Ministers, carry the Word with you, and be ready to use it to speak truth into the lives of members when you make home visits.
 - Deacons Lead in Practical Service-Show the other members what service looks like and get them involved. This will not only free up the minister of the word, but a church that shows "love one for another" will be a better witness to the world.
 - Use your Experts-Utilize your members that have specific knowledge as it pertains to some of these philosophies.

The Church-Church Dynamic

While the churches of the New Testament were autonomous, they were not islands to themselves. They were a help to one another. The church at Jerusalem gave a recommendation to several Gentile churches concerning a doctrinal issue (Act 15:1-31). Several of the churches also came together to financially relieve the saints in Jerusalem (1 Cor 16: 1-4; 2 Cor. 8-9). Our concern for God's people ought to extend beyond our own congregation. We are all suffering the consequences to conforming to the world in thought, word, and action. Let's help each other.

It seems appropriate, as we conclude the subject, to encourage our audience to refuse be intimidated. 1 Corinthians chapter one assures us that the wisdom of this world is not to be compared with God's wisdom. "Because the foolishness of God is wiser than men, and the weakness of God is stronger than men," (1 Cor. 1:22). We serve an All-Knowing God Who not only has access to our hearts and minds, but those who support the harmful philosophies of our culture. If we find ourselves lacking the wisdom to properly contend for the faith (Jude 3), we have the assurance from God's word that He will give us wisdom if we ask; He gives to all generously and He will not reproach us for asking (James 1:5). Refuse to be intimidated.

"...For the weapons of our warfare are not of the flesh, but divinely powerful for the destruction of fortresses. We are destroying speculations and every lofty thing raised up against the knowledge of God, and we are taking every thought captive to the obedience of Christ..." (2 Cor. 10:4-5).

Following the reading of the subject, a motion and 2nd was made to adopt the report. The following brethren came forward to speak on the subject: Brother Nick Reuter, Brother Bruce Adamson, Brother Jonathon Elliott, Brother Larry McClain,

and Brother Brad Hicks. A question was called, vote taken, and the subject was adopted.

Following the adoption, Brother Moran then called upon Brother Jeff Brown to present the second subject: "<u>God's Sovereignty vs Human Responsibility</u>".

- 1) What does the Bible teach about God's sovereignty?
- 2) What does the Bible teach about human responsibility?
- 3) How does the Bible reconcile these two doctrines and what can we gain from them to deepen our knowledge of God and our purpose as His people?

The goal of this subject committee is to first define both questions and separate the topics; then reconcile the differences between the two views as it relates to Gods word.

1) What does the Bible teach about God's sovereignty?

The first thing that must be done is to define the word sovereignty. **Sovereignty** is the full right and power of a governing body (*in this case, God*) over itself, without any interference from outside sources or bodies. (Etymology)The term arises from the unattested Vulgar Latin's *superanus, (itself derived form of Latin super - "over") meaning "chief", "ruler". (From Wikipedia)

The three great monotheistic religions Judaism, Christianity, and Islam maintain that their God is absolutely sovereign! While many other religions maintain that their god or gods are very powerful yet most were plagued with flaws. As an example, the Greek god Zeus reportedly cohabited with women of the human race producing offspring. Almost all possessed very real weaknesses similar to human weaknesses. This is not surprising, because these false deities were invented by human beings. In addition, there was always a tension between the various or local gods and surprisingly enough, most cultures were more than willing to acknowledge other gods as long their gods were also acknowledged. There were many contests or wars among local cultures as to which gods were more powerful. It does not appear that many if any of these cultures claimed that their deities were absolutely powerful or absolutely sovereign.

For Christians, there are several dozens of quotations from the Bible that at the very least suggest a sovereign being is in charge of everything. According to the bible, Jehovah God created the heavens and the earth out of NOTHING and maintains them or upholds them by His power. (Gen 1:1) Jehovah is a supreme God and has "omni" attributes. He knows all, sees all, is everywhere. (Psalms 139:7-12) He does not change as he has no need to. He is eternal or better timeless, and very importantly is self-existent. The reason for His existence lie solely in His will and nature. (Mal 3:6) Jehovah has absolutely perfect moral attributes! He is good, just, truthful, loving, wise, and holy and according to His own testimony, there are no other gods. (1 Kings 18:17-46)

Can Jehovah God do absolutely anything and everything he wants to? Does he have absolutely no limitations? The surprising answer to many is no. He does have limitations! For one, God cannot lie and it would be totally against His divine nature (Psalms 31:5). Likewise, He could never create a rock so large and heavy that He could not lift it as it would be totally illogical. God cannot do or create anything

that is illogical. A few examples may be in order. He cannot make a married bachelor, they are mutually exclusive, a man is either a bachelor or he is married. He cannot make a square a triangle. The properties of a square require that it is a four-sided object where as a triangle's essential properties demand that it is three sided. Once again to suggest otherwise would be illogical and Jehovah God is very logical. Why can't He do those things mentioned? HIS NATURE! Human nature determines what humans can and cannot do, likewise the very nature of God (His nature is who He is) determines what He does. God is not a man that should lie, God declares that he does not or rather that He cannot change. God's nature forbids Him to do things that He cannot and will not do. Numbers 23:19 God is not a man that he should lie; neither the son of man, that he should repent: hath he said, and shall he not do it? or hath he spoken, and shall he not make it good?

What does the Bible teach about human responsibility?

The first man, Adam, was created as a righteous man free from sin and its consequences. He was given free will, providing him the privilege to make a choice. The choice that was set before him was obedience or disobedience, resulting in life or death. (Gen 2:16-17) No other man born thru his seed has since been given the same choice. In his disobedience Adam chose death and the consequence of his choice has passed upon all humanity, "Wherefore, as by one man sin entered into the world, and death by sin; and so death passed upon all men, for that all have sinned:" (Romans 5:12)

Man, in his lost condition and apart from the influence of God is not searching for God. "As it is written, there is none righteous, no, not one: There is none that understandeth, there is none that seeketh after God." (Romans 3:10-11) As the good shepherd searches for the lost sheep, God is searching the minds and hearts of man in an attempt to retrieve that which was lost. "For the Son of man is come to seek and to save that which was lost." (Luke 19:10)

Through creation God is calling mankind to consider His power as creator. "The heavens declare the glory of God; and the firmament sheweth his handywork. Day unto day uttereth speech, and night unto night sheweth knowledge. *There is* no speech nor language, *where* their voice is not heard." (Ps 19:1-3) He is speaking clearly and must be heard. "For the invisible things of him from the creation of the world are clearly seen, being understood by the things that are made, *even* his eternal power and Godhead; so that they are without excuse:" (Romans 1:20) In consideration of the created world, man's responsibility is to take notice of its thoughtful design and enquire who it's architect must be and what plans He has for him. This inquiry will not go without a response from God.

Through the "gospel of His dear Son" God is calling "all men everywhere to repent." (Acts 17:30) Through the work of the Holy Spirit His word is made alive in our hearts, making us aware of our sinful condition by awakening our conscience to the sin sickness that afflicts us. This is done in order to bring us to a place where we willfully submit ourselves to the care of the Great Physician. As a sick man will never seek a cure for his illness till he comes to terms with the fact that he is indeed sick,

even so the sinner once made aware of his sin must not run from it, but determine to go to the One who alone has the remedy. That same sick man can do nothing but present himself to the care of the physician and wait for the help he requires, even so the sinner presents himself to Jesus Christ as nothing more than a poor sinner and cry out for Him to be "merciful to me a sinner." (Luke 18:13)

God is calling and man's responsibility is to respond to the gospel call. The choice which is set before Adam's race is whether they will remain in a state of rebellion and resist the calling of God or whether they will respond to the calling of God by humbly submitting themselves thru "repentance toward God, and faith toward our Lord Jesus Christ." (Acts 20:21)

- 3) How does the Bible reconcile these two doctrines and what can we gain from them to deepen our knowledge of God and our purpose as His people?
 In order to effectively reconcile these two doctrines, we will provide answers through three main points.
 - God loves his people and receives glory from our free will of worship and servanthood.

As we have read God is completely sovereign and also allows His people to make decisions in their lives that will have a positive and Godly effect in their walk or His people will make poor decisions that will negatively affect their lives. In order to do this, we must draw our attention to why God chose to make human kind. God is perfect in every way and did not need to create something out of nothing to fulfill a need. God was not lonely or unfulfilled as these types of feelings are not of God. When God created the universe and everything contained within, it was with purpose and order. We find when God created everything from day one through six, it was purposeful and in order. Day one he created light and day two He created the firmament and the atmosphere. In day three He created dry land and seas. (Gen 1:3-10) Can you imagine creating the light after the heavens or the dry land before light? On the sixth day God made man which He created in his image and gave man dominion over all things because God had a purpose for mankind. (Gen 1:26-28). God's purpose for mankind was to populate the earth and live happy lives and He intended it for the first family. After God created Adam he determined that Adam would be happier with a help mate and then created Eve. (Gen 2:18) God Jehovah created the perfect atmosphere for all of the living creatures to dwell and live in peace and harmony. In the Garden of Eden there lived the first couple who had favor with the Lord but were given instructions and a choice of a path to choose. Gods' instruction to Adam was to eat freely of the garden but to avoid the tree of knowledge of good and evil. God was sovereign and all-knowing but allowed his first creation to make a choice to follow HIS instruction and live eternally or to make a wrong choice and die.

God knew the choice that Eve, and eventually Adam, would make but yet He created them for his Glory and to Love and worship HIM freely of their choice. (Isa 43:7) Even before He created the first family God knowingly allowed Satan to rise up in pride which allowed sin to enter into Heaven and eventually earth. (Isa 14:12-15)

Did God know the choice of Lucifer and his effect on humankind and the eventual outcome? Of course He is God.

God loved his creation so much that He created them in His image. (Gen 1:26) He also loved his creation so much that he sent his only begotten son to deliver his people from their own sin and destruction. (John 3:16). For centuries mankind has constantly questioned God's sovereignty and rule but the fact is that mankind was put onto this world by a loving God which was free of sin, but it was mankind's choice to allow sin to enter into her race.

- God gave us instruction to allow us to make proper choices. Even though His creation allowed sin to enter into this world, our sovereign God Jehovah developed a plan for the redemption of His people and has given His people the instruction of almost fifty prophets, sixty six books and nearly eight hundred thousand words of instruction to reform his people and allow them to freely worship Him. As mentioned above, there is a constant calling from God to his people to repent of their sins and to depend upon Him for their salvation from the depths of hell. (Joel 2:12-13; Luke 13:2-5; 2 Cor 7:9-10) We find in the Old Testament that God warned the children of Israel to not elect a king because He knew their heart would turn away from Him. (1 Sam 8:6-10) Yet the children of Israel were allowed to make a choice in a king which ultimately turned their focus away from God. Even after the law was accepted by the children of Israel, they perverted the law through their works and had forgotten the instructions from Jehovah that their repentance was a heart condition and not of works. Our Savior died to fulfill the prophecy so that man could clearly understand the Law of God and His love for mankind. (John 19:28-30)
 - God never saved a person without their desire to repent and Gods desire to save them.

In order to be saved a person must come to the knowledge that they are a sinner and are separated from God. The sinner must realize their separation from the creator of the universe and ask for repentance to be saved from an eternal hell. The scriptures are filled with a call to repentance and therefore implies that all who desire salvation must seek after salvation from the Lord. (Heb 11:6; Eph 1:12-13) In addition, God desires that all of His children repent of their sins and to be cleansed through the blood of His son Jesus. (2 Cro 7:14; Acts 17:30; Rev 3:20). All of these scriptural accounts indicate a bilateral desire from both parties to obtain the free gift of salvation. It is not one sided as some views might suggest.

In conclusion, it may seem impossible to attempt to reconcile these two different poles of belief but consider this. If a sovereign God decided to create the heavens, the earth and mankind, and His number one priority was to give man free will who are we to challenge His will? Thus He did, and He had to know (and did know) that there was a real possibility that mankind would rebel against Him and actually hate Him. Is not the sacred word a living testimony and history of God's loving endeavor to recover and save his fallen creatures? Of course it is, He loves His creation with eternal love that while on this earth we cannot fully comprehend. We do however see a glimpse of His great love through the gift he gave to mankind for the eternal redemption of their souls. (John 3:16)

Following the reading of the subject, a motion and 2nd was made to adopt the report. The following brethren came forward to speak on the subject: Brother Jeff Brown and Brother Jeremy Miller. A question was called, vote taken, and the subject was adopted.

Brother Moran asked Clerk Brother Chris Harper to come forward and read the minutes of the day. After the reading of the minutes, a motion and 2nd to approve the minutes to this point was made. Motion carried.

A motion and 2nd was made to dismiss until 7pm. Motion carried.

Friday, September 14th, 2018

Evening Session

Brother Cory Houchens and Brother Brad Hicks began the service by singing I'm Bound For That City, and Son Go Bring My Children Home.

After the song service, Our Moderator, Elder Jeff Moran, welcomed everyone to the evening session. He thanked the congregation for making their way back this evening. He stated that this service is a good opportunity to remember our dear brothers and sisters that have passed on and remember their good works.

Brother Moran opened the floor for prayer requests before prayer. There were several requests and hearts were burdened for lost souls. He asked Brother Jeff Elliott to lead the congregation in prayer. After prayer, the assistant clerk, Brother Jeremy York, came forward to call the roll of messengers. With 32 messengers present and 12 churches represented out of a possible 15 a quorum was called.

Following the messenger roll call, Brother Moran asked Brother Stephen Thompson to come forward to read the Obituary Report and read the list of the dearly departed. (**Obituary Report on page 42**)

Memorial Sermon

Elder Stephen Thompson

After the report was read a motion and second was made to adopt the report. Brother Moran asked Brother Cory Houchens and Brother Brad Hicks to come forward to lead *The Love Of God*. It was then requested that Brother Brad Hicks sing *We Have A Hope*. Following the songs, Brother Stephen Thompson came forward to bring the memorial sermon.

Memorial Sermon

Brother Thompson thanked the churches for the opportunity to be here and stand. He said that it's almost been 37 years since he had announced his calling to preach, and he still needed the Lord's help. He thanked God for the services thus far and called our attention to Proverbs 4:23 - "Keep thy heart with all diligence; for out of it are the issues of life."

He began his sermon by reading John 11:18-45. He said that there was so much teaching about Jesus and his compassion in these passages of scriptures. In this passage of scripture there was more theology than all the theologians of this world could ever come up with. He pointed out that Thomas, Didymus, asked that he would die so that the savior could raise him. What a picture of salvation of a soul dying to sin and being raised in newness of life.

Brother Thompson said that Jesus desired to show the people in this account about the compassion of God. Jesus completed so many works in his life and through his death. Jesus wept for his friend, and the congregation commented how much Jesus loved Lazarus. Jesus weeps over us. He desires for his people to draw close to Him and have that close relationship that every father desires for their children.

Brother Thompson pointed out that Jesus wanted Mary to believe and pointed out that her faith was week. Jesus wanted her to recognize that He had power over life. When Jesus asked that the people remove the stone covering the grave of Lazarus, He said that "if thou wouldest believe, thou shouldest see the glory of God." Again, the Glory of God is his power over life! He said that he was saved as an 8-year-old boy and his grave clothes were gone and stood as a newborn child of God.

Brother Thompson read Philippians 3:7-11, saying that out of everything we could have in this life there was nothing more important than attaining Christ. Christ is should be the full focus of our aim in life. He asked the churches to pray for one another and encourage one another to hit the mark. We should be as the archer shooting for the bullseye and not just aiming at the target. (find a video of the full sermon online at www.bethelmba.com)

After the sermon, Brother Moran thanked God for the message. He said that the family members that were present that had lost loved ones this past year were in our prayers. He exhorted us to encourage one another in these last days. Brother Moran then asked Brother Cory Houchens and Brother Brad Hicks to come forward to lead a few congregational songs while we shake hands with Brother Thompson. Beulah Land, and He'll Hold My Hand were selected for the handshake.

After the song service, Brother Moran entertained a vote to adopt the Memorial Report. The vote was taken, and the motion passed. A motion and second was made to adjourn until Saturday morning at 10am.

There were several prayer requests and announcements made at the end of the service, and there is a need for the Lord's help. Brother Moran asked his father, Elder Billy Moran to lead the congregation in a dismissal prayer.

Saturday, September 15th, 2018 Morning Session

Brother Cory Houchens welcomed the associational messengers and lead the congregation in singing *Because He Lives* and How *Great Thou Art*. Brother Brad Hicks accompanied on the piano. After the wonderful singing, Moderator Elder Jeff

Moran began by welcoming each one back to the Saturday Morning session of the 62nd Bethel Associational meeting. Brother Moran then called for any prayer requests. After requests, Brother Moran called upon Elder Del Compton to lead our hearts in prayer.

Following prayer, Brother Jeff asked association clerk, Brother Chris Harper, to come forward and read the roll of messengers.

With 14 churches present, and 49 members in attendance, a quorum for transacting business was declared. (Roll of Messengers on page 14)

Brother Moran requested that any new visitors make themselves known before the association. In attendance was:

Brother Del Compton, Calvary MBC, Bolivar, MO, Hope County Association

Brother Moran then asked Brother Houchens to come forward and lead the congregation in a song as we collect the missions offering. Brother Houchens lead Thank You Lord. Brother Jonathon Elliott requested Brother Brad Hicks to sing *We have a Hope*.

Following the special song, Brother Moran then asked Brother Jonathon Elliott to come forward and bring the doctrinal sermon.

Doctrinal Sermon

Elder Jonathon Elliott

Elder Jonathon Elliott began by thanking the association for the opportunity, all of the efforts and services thus far in the meeting. He states he is humbled at the opportunity in presenting the word in the doctrinal sermon. He spoke to he as a preacher is just a vessel and presenting what thus sayeth the Lord. He asked for prayer for the word, and for our hearts and ears to hear.

The Doctrine of God's Wrath

Brother Elliott spoke to a coworker asking a question recently that was "Do you serve a benevolent God or a loving God?" He spoke to his coworker not having a clear understanding of who God is. The question itself implies God can't be both. The world thinks talking about the wrath of God is what is wrong with religion, gives the wrong idea of religion. These thoughts of society has infiltrated the minds of the church and the minds of our ministers and cause people to believe we cannot discuss the things of God or that we have to make some sort of excuse for Gods wrath so that it sits better for the hearers that are listening to us. It comes from not knowing who God is. Our prayer is that he opens our hearts to who he really is.

Brother Jon then referenced multiple scriptures referencing how loving God truly is. He has proven who he is over and over again, GOD IS LOVE! However, God does not make any attempt in concealing his wrath either. There are hundreds upon hundreds of references to his wrath as well. So, the answer to the question to the question "Is God a God of wrath?" Unequivocally yes!

God is both a God of love and wrath. We as individuals misunderstand the love and wrath of God. God is in no way like us, he is above us and higher than us. When we compare him to us, we misrepresent him as a whole. Don't ascribe the wrath of man to God, it is not inconsistent. His wrath is arisen from one thing, evil. Comes from nothing else. His wrath is consistent.

God is perfectly good, and just. He is made to be angry because of evil. God's love and wrath are not against each other. In our mind, it does not add up. The world does not want to hear that it is possible. If we do not have a change in our hearts(salvation) we will forever feel his wrath. Propitiation was necessary and the God of wrath and anger was the one who initiated it! God appeased his own wrath by giving us Jesus. God initiated it and Christ accomplished it. For our sakes, God made Christ who knew no sin to be our sin. Became our sacrifice. It pleased the Lord to bruise him. God's indignation towards sin was satisfied by his perfect Son's sacrifice.

If you are an object of God's wrath, flee from the wrath to come. THERE IS A HOPE. We can win victory over sin in Jesus Christ. Be sure you are safe and secure in the blood of Jesus Christ. Nothing should make us more zealous than sharing the hope of Jesus Christ! God has righteous anger towards sin and so should his believers.

Ephesians 2:4-10 But God, who is rich in mercy, for his great love wherewith he loved us, even when we were dead in sins, hath quickened us together with Christ, (by grace ye are saved;) And hath raised us up together, and made us sit together in heavenly places in Christ Jesus: that in the ages to come he might shew the exceeding riches of his grace in his kindness toward us through Christ Jesus. For by grace are ye saved through faith; and that not of yourselves: it is the gift of God: Not of works, lest any man should boast. For we are his workmanship, created in Christ Jesus unto good works, which God hath before ordained that we should walk in them. Brother Elliott finished by thanking God for the glorious news of the gospel and that our only hope relies solely in the propitiating sacrifice of Jesus Christ. Brother Moran praised the Lord for the good message. After testimonies, Brother Cory Houchens came forward to bring a few congregational songs and allow time for the association to pass by and shake hands with Brother Elliott. Brother Houchens led *Jesus Paid it All* and *Amazing Grace*.

Following the handshake and further testimonies, Brother Moran entertained a motion and 2nd to suspend further business and adjourn for lunch until 1p.m. Motion carried. Brother Moran called upon Brother Monty Shoulders to pray a blessing over the fellowship and lunch.

Saturday Afternoon

Brother Cory Houchens welcomed the association back after lunch and we sang *I Can Tell You Now the Time*. Brother Brad Hicks accompanied on the piano.

Following the song, Moderator Elder Jeff Moran called the association back to order. Elder Moran called our hearts to prayer and asked Brother Jimmy Whitney to lead us to the throne of grace.

After prayer, Brother Jeff asked for Brother Andrew Horton, Chairman of the subject "The Association's Purpose and Desired Effect", to come forward and present the subject.

What is the Biblical purpose of the annual association meeting? In what ways can we improve the structure or format to better achieve its purpose? Traditionally the Association meets (2) days out of the year. Are there ways to utilize the resources, finances, talents of the association to enhance these efforts?

It is easy for those who have invested minimal time and energy into something to criticize it, and it is equally easy for those who have invested a considerable amount of time and energy into something to immune themselves to any criticism. In fairness to both, when we consider this topic we must proceed with honesty and humility. Humility, because after serious consideration some skeptics may learn that our predecessors (in a different time and under different circumstances) developed an institution that played a pivotal role in establishing sound churches. But, we must also proceed with honesty. If we desire to carry out the commission of The Lord and maintain orthodoxy in both doctrine and practice, then we must address the true state this association. This report is our attempt at a humble and honest analysis of the association. We have tried to accurately gauge the present utility of this institution and whether the format and structure of our association is biblical, and most beneficial as it is presently constructed. As a whole we find it well constructed; However, in a few areas we recommend modest changes to enhance its effect.

As our committee discussed this topic and informally polled various associational participants what quickly became evident was the lack of understanding regarding the purpose of the association.

Much of our <u>younger generation</u> thought it was largely an outdated gathering of "old men" who "talked about stuff." The ones who grew up in church grasped a semblance of purpose, but struggled to see the association's relevance and benefit to their church, and respectfully questioned its utility. Common questions we heard were:

- What is the association trying to do?
- Is the association a year-round thing or is it just a once a year thing?
- Can anyone attend? What can non-messengers do?

As for the <u>older generation</u>, they understood more clearly the broader purposes of the association but explained it with hesitance and uncertainty. Some said the association's purpose was to discuss important topics the churches should consider about doctrine and practice. Some said it was merely a weekend of fellowship meant to cultivate the relationship between the churches. Others said it was to foster encouragement and redirect our churches in the paths of righteousness.

These are all good answers. But what became evident to our committee was the lack of clarity about the purpose of the association.

In the scriptures, we do not see any type of formal associations as we have in modern times. But we do see things that resemble what can be considered an *informal* association. What we mean by informal associations: occasions when churches are spoken about collectively or accounts when groups of elders (presumably from different local churches) are called together to counsel the early churches. Examples include:

- -The dispute about circumcision following Paul and Barnabas first missionary journey (Acts 15)
- -Paul's letter to the *churches* of Galatia (Galatians 1:2) where he addresses doctrinal and practical issues this group of churches had gotten wrong.
- -Jesus words of encouragement and correction to the *churches* of Asia Minor in the book of Revelation (Revelation Chapters 2 and 3)
- -Peter's explanation to the Judean elders about the expansion of the church to the Gentiles and his experience with Cornelius (Acts 11)
- -Associational teachers or representatives sent to young Gentile churches to establish doctrine, identify false teaching, and encourage sound behavior (Acts 15)
- -An offering is sent by the Gentile churches to the church(es) in Judea because of a famine (I Corinthians 16:4; Acts 11:27-30)

In each of these accounts, we find a variety of reasons for the interconnectedness of the early churches: instruction, reproof, encouragement, charitable contributions, and mission support to name just a few. *It seems as though the purpose of their association was contingent on the challenges and circumstances confronting them at the time.* If they were falling into doctrinal error, instruction and reproof became the predominant reason for their meetings. If one of the churches needed financial support, they contributed to their relief. In all of these situations the early church clearly identified the purpose of their actions, discussed it, and strove to carry out whatever solution God helped them to identify. Because of this pattern, they were able to successfully address the

actions, discussed it, and strove to carry out whatever solution God helped them to identify. Because of this pattern, they were able to successfully address the pressing challenges of their time. The Judean believers were relieved of their hardship during the time of famine. The Corinthian church repented of their sin because of Paul's reproof. The Jewish elders clinging to circumcision were corrected of their doctrinal error. Teachers were sent to young churches to help establish doctrine and practice and were welcomed by those gentile Christians.

It is vital that we recognize that none of these things appeared to be done with the intention of usurping authority from the local congregation, nor does it seem like these actions were interpreted that way. The intent of the apostles was clearly a love for God and their fellow brethren, and as a result they were received with joy, not suspicion or dread.

In the Bethel Association, we know of no church or messenger present today that has the desire to usurp authority over any other church in the association. Nor do the signs of such an inappropriate action seem to be on the horizon. We do, however, see these churches facing challenges which we are all struggling to address in one way or another.

And so, the following recommendations are humbly presented to improve the association's effect and to better utilize the various gifts which are collectively held.

Pass a resolution which clearly identifies short-term and long-term goals we
want to see addressed. In the pattern of the apostles, we think it would be
helpful to periodically establish short-term and long-term goals which identify
the challenges our churches are collectively facing, and that we desire the association to tackle jointly. Once we identify them, it will give a tremendous

amount of guidance to those who will participate in the association in the future. It will help the subject selection committee identify subjects. It will help all participants better prepare to attend the association. Ministers who are preaching will be able to better know what doctrines and practices are being questioned or compromised.

These resolutions could include topics such as: the attrition of our young people, how to incorporate new music in church, ministerial education, how to support widows and orphans, aiding addicts in the church, how to assist single parents in the church, and other topics that are both doctrinally and practically relevant. *Churches would participate voluntarily* after the close of the associational meeting, but the annual meeting would present a good opportunity to discuss the matters in one setting.

- 2. Allow each church to select a member of their church to be on the subject selection committee. Since a large portion of our annual meeting is dedicated to subjects, the topics discussed at the association are often dictated by the interests, age, and church culture of the members of the subject selection committee. For our subjects to cover a wider array of concerns which are actively affecting the churches, it may be helpful for the committee to meet once a year (or more based on the committee's desire) to discuss what doctrines and practices need to be addressed at the time. The associational moderator could serve as moderator of this group (with no vote unless his church selected him to represent them) and each church could select one of their messengers to serve on this committee.
- 3. Find a way to engage our young people. Each year the average age of our associational participants gets older. Many of the younger men, including those on this committee, are young ministers who may or may not always be a part of this particular body. To ensure a stable future, it is vital that the association begin engaging and training young men and women (especially non-pastors) to support and participate in this body. There are tasks and procedures of this body that will not come instinctively to our next generation, and must be taught with a measure of love, and with a measure of persistence. A failure to do this will become noticeable in the very near future.

In conclusion, our committee believes the association is a valuable institution and has done much good for the churches involved for multiple decades. It has served as a measure of fellowship, and has brought about innumerable subject and sermons that have helped shape all of our churched in one way or the other. We further believe that modest changes can be made to better address the concerns facing all our churches. At the heart of each of these recommendations, is the hope that our relationships with each other will grow deeper and help one another to address the problems we all face.

Following the presentation, a motion and 2nd was made to adopt the report. Speaking to the subject were: Brother Andrew Horton, Brother Monte Botkin, Brother Danny Edwards, Brother Del Compton, Brother Jeff Moran, Brother

Jonathon Elliott, Brother Bruce Adamson, and Brother Terry Foster. A question was called, vote taken, and report adopted.

Brother Moran then called upon Brother Jeff Thompson, Chairman of the Missions report, to come forward to present the report. A motion and 2nd was made to adopt the report. Speaking to the subject were: Brother Jeremy Miller, Brother Monty Shoulders, Brother Jeff Moran, Brother Kenny Turner and Brother Scott Hauskins. A vote was taken and report adopted.

Following the mission report, Brother Jeff Moran asked Brother Jeremy York, Chairman for the Correspondence committee, to come forward and present the correspondence received, and the letter we will send to the other associations. A motion and 2nd was made to adopt the report. A vote was taken and report adopted.

Brother Moran then called upon Brother Cory Houchens to bring the financial report. Following the report, a motion and 2^{nd} was made to adopt the report. A vote was taken and the report adopted. (Report on page 38)

Old Business

Brother Brad Hicks came forward to present the "<u>Bible Translation</u> committee report".

The Translation Committee presented their report using Microsoft Power-Point. There was no written copy of the presentation. Within the presentation the committee presented the history of the King James Bible, the history of ancient biblical manuscripts since the King James Bible, the various translation approaches, the process they used to research other translations, and concluded with a recommendation of the New American Standard Bible. At the end of the presentation they made the following recommendations to the association:

- As a supplemental reference source.
- In parallel studies with both KJV and NASB during personal devotions.
- In parallel usage during church services, especially mid-week Bible study or during Sunday School.
- Placement of copies of the NASB in the pews, so that if a teacher/preacher references this version, congregants would be able to follow along.
- Follow-up meetings to provide a forum in which all our churches could discuss their usage experiences and share helpful/best practices.

Following the report, a motion and 2nd to adopt the report were put forward. Speaking to the report were Brother Brad Hicks, Brother Jeff Moran, Brother Jeremy Miller, Brother Dereck Mobley, Brother Bruce Adamson, Brother Jonathon Elliott, and Brother Darrell Cochran. Report adopted.

Discussion was held on the motion from 2018 about an associational ambassador. During the discussion, the main request of the churches present was more clarity/definition around the position.

New Business

Brother Moran then called on Brother Tyler Kemp to bring forward the subjects for the 2020 association. A motion and 2nd was put forth to adopt the subjects for presentation. A vote was taken, and the subjects adopted.

2020 Subjects for Presentation

1. The Necessity of Personal Evangelism-

- What effect does a decline in personal evangelism and Soul winning have on our churches, our communities, our circles of influence, and for the advancement of the Kingdom as a whole?
- What, if any, additional enterprises can our churches pursue in effort to aid in our endeavor to Win Souls to the Lord?
- What existing hindrances impede personal evangelism among our members, and what steps or tools can be utilized to aid in the reversal of the decline of personal evangelism?

2. Just, Faithful, Exemplary-

- What effect can unfavorable deportment, unjust dealings, and unfaithful commitment have on the local church? Also, how does this effect our ability as Christians to outreach to those we contact outside of the body of Christ?
- What hazards arise when unbecoming deportment is present within our Churches, and what benefits and blessings come from holy relationship and interactions among members?
- What biblical truths can be applied to this matter in a measure to ensure our consecration toward Holy living, as a means of more accurately reflecting the Nature of God?

Motion and 2nd to adjourn until September 18, 2020 at 10am, with Bethel Missionary Baptist Church. Motion carried.
